F.Y.I.

People's Choice tasting starts at 2:00 pm Saturday and 1:00 pm on Sunday. Teams can participate in People's Choice tasting for both days with the public judging. *Taste tickets are for a 2 oz sample of BBQ categories only.* Each PERSON purchasing taste tickets will obtain, in addition to tickets purchased, a different colored ticket. After sampling is completed, each person tasting will drop the different colored ticket at their favorite BBQ team booth, in a container provided by Fairgrounds (all tasting tickets will be counted, 50% value collected going back to BBQ team). In addition to the tasting ticket money, the People's Choice Champion will receive an award along with bragging rights.

- KCBS Team check-in will begin at 9:00am, September 30<sup>th</sup>.
- Meat Inspections will begin at check-in
- For KCBS rules and regulations go to kcbs.com
- 2 tickets per team given for Cook's dinner Fri. 6pm. Additional tickets are \$10 and must be requested by September 19<sup>th</sup>
- Cooks meeting will begin at 7:00 pm Friday evening
- Live BBQs should be attended to at all times
- Potable water is available for all cook sites (One cook site per team) (Please bring your own splitters & hoses)
- Sunday's Grill-Off check-in will be 7:00 am with meat inspection to follow. (Sunday teams may arrive Sat eve and KCBS teams on site will perform meat inspection).
- Gray water must be hand trucked to kitchen located near BBQ area, no ground dumping!
- Grease containers will be provided near BBQ area, no ground dumping!
- Ash containers will be provided and are for ash only (No Trash)
- A min 5 lb charged fire extinguisher must be visible at each pit
- All teams must leave their cook-site as clean as they found it
- This is a family event, please use good taste in the display of all banners, etc
- One vehicle per team may be kept near cook-sites; event staff will determine location
- Event held rain or shine / No refunds.
- Friday night - Quiet time is 11:00 pm to 7:00 am – Violators may be subject to disqualification

Liability Waiver

1. Licensee agrees to maintain and return the premises herein permitted to be used and other portions of the premises of the Association to which it, its employees, agents, licensees, or any member of the public has access to by reason of this agreement in the same condition as the premises were before use of the same was permitted hereunder, ordinary wear and tear, acts of God, or casualties beyond the control of the Licensee, excepted.

This duty of Licensee to indemnify and save the County, the State, the Association, and each of them harmless includes the duties to defend set forth in California Civil Code section 2778.
